Excerpt from the November 4, 2009 COB Bylaws, Article IV

According to the November 4, 2009 COB Bylaws, Article IV. Membership of College Teams "**Section 1.** Tenured/Tenure Track faculty members, excluding departmental chairpersons, who have regular appointments in the College of Business and who have been tenured/tenure track faculty members at Illinois State University for at least one full academic semester preceding the election shall be eligible for election to a College Team, unless they are on leave at the time of election, or have requested leave for the whole or part of the following academic year, or are on disability leave under the State University Retirement System. All faculty, staff and students are eligible for appointment to any Team. **Section 2.** Annually, the Human Resource Development Team, the Curriculum Team, the Technology Team, and the Constituent Satisfaction and Outreach Team, shall elect a team leader, or chair, from among the elected faculty members on the team. **Section 3.** Tenured/Tenure track faculty members of the College of Business are eligible to vote for their departmental team representatives. **Section 4.** All faculty, staff and students are eligible for appointment to any Team. After the department elections are complete, faculty and staff will be polled and given the opportunity to indicate, in priority order, the teams on which they would like to serve. **Section 5.** Size and selection of each college team shall be as follows: College Coordinating Team: The College Coordinating Team shall consist of the chair or leader from each of the four college teams: Human Resource Development; Curriculum; Technology; Constituent Satisfaction and Outreach. The Dean of the College of Business shall be a nonvoting member. Human Resource Development Team: The Human Resource Development Team shall consist of one member elected by each department, and up to three additional members appointed by the Dean. Curriculum Team: The Curriculum Team shall consist of one member elected by each department, and up to three members appointed by the Dean. Technology Team: The Technology Team shall consist of one member elected by each department and up to three members appointed by the Dean. Constituent Satisfaction and Outreach Team: The Constituent Satisfaction and Outreach Team shall consist of one member elected by each department and up to three members appointed by the Dean **Section 6.** The terms of office of all elected team members shall be two years. Terms shall be staggered so that terms of two elected members of each team shall expire each year. Team members shall serve no more than two consecutive terms. (Filling another member's vacated position shall not be construed as having served a term.) Appointed team members shall serve terms of one year."
