Turner has had an extraordinary 37+ year career providing leadership, expertise and service within the insurance industry. Turner initially joined Ryan Specialty in 2010 to create and develop Ryan Turner Specialty (RT Specialty), Ryan Specialty's wholesale brokerage division. Under Turner's exceptional strategic leadership, RT Specialty is now one of the top wholesale distributors of specialty insurance in the country and known for its expertise and outstanding client service. On October 1, 2024, Turner succeeded Pat Ryan as CEO of Ryan Specialty, leading the firm forward through a period of remarkable growth and success.

Prior to joining Ryan Specialty in 2010, Turner was the President

of CRC Insurance Services, Inc., one of the largest wholesale insurance brokers in the U.S. at the time. Turner joined the Crump Group in 1990 as a casualty broker, quickly distinguished himself as a leader, and was named President of the Chicago office. Turner began his insurance career as a casualty broker with A.J. Renner & Associates in 1987.

Turner has received a number of awards, the most recent being chosen as the Katie School Hall of Fame Laureate 2024. Additional awards include being inducted into *Insurance Business America*'s Hall of Fame in 2022 and being named the 2021 Spirit of Life Honoree by the National Insurance Industry Council and City of Hope. In 2020, the *Insurance Insider* named Turner the Distribution Leader of the Year, honoring him as the year's most influential and outstanding individual in insurance distribution. In 2019, Turner received the prestigious Insurance Industry "Good Scout" Award from the Boy Scouts of America, Greater New York Councils.

Before joining the insurance industry, Turner graduated from the Detroit Police Academy, served on the Wayne County SWAT Team, and was an undercover narcotics officer with the Narcotics Cocaine Task Force with the Michigan State Police.

In 2019, Turner co-founded the Robert J. Turner Foundation, whose mission is to honor courageous police service men and women and to make a lasting impact on the families of fallen officers. A graduate of Madonna University, Turner holds a Bachelor of Science degree in criminal justice and is a member of the university's board of trustees.

About the Katie School of Insurance and Risk Management



Since 2010, I have served on the Katie School Advisory Board of Executives. As an employer and an alumnus of Illinois State University, I appreciate what the Katie School does in preparing students for the industry. The Katie School of Insurance

and Risk Management at Illinois State University is a unique center of educational excellence. The Katie School was established in 1991 and helps to prepare over 300 students annually for careers in insurance, risk management, and actuarial science. The Katie School provides scholarships to attract top students and works with students and faculty to help develop "ready to go" graduates for the insurance industry.

The Katie School has set the standard for how to prepare students for the insurance industry by offering customized curriculum, industry connections, and cutting-edge courses. The Katie School's distinguishing hallmark is its connection to industry. That is unique. It works with the officers in Gamma Iota Sigma to bring over 90 industry speakers to campus each year. Through Katie School support, students attend numerous industry conferences where they participate in sessions and network with industry professionals. The Katie School is well-known for its global perspective and fully funds international internships in London, Bermuda, Zurich, and other countries on an annual basis.

The Katie School recognizes that the next-generation insurance workforce will not only need technical knowledge but will also need to leverage that expertise through critical thinking, negotiation skills, communication, and collaboration. To better address these requirements, the school has designed workshops, seminars, and one-on-one instruction to teach students these critical soft skills that have become differentiators in the digital age.

The Katie School works with leaders in the insurance industry to set students up with research projects tackling the latest emerging hazards and challenges that are present in the risk management environment. Some of these students have gone on to present their research to industry leaders at board meetings and at industry symposia. Students working with the Katie School understand that the value of their college education goes well beyond credentialing.

The Katie School provides support for high school programs including a weeklong program, Redbird Risk Management, where students learn to manage the risks associated with a business. The program includes additional focus on inclusion efforts meant to attract a diverse pool of potential students to the Katie School of Insurance that may not otherwise be considering academic pursuits that would lead to career potential in the insurance industry. The Katie School believes in lifelong learning and offers programs for industry professionals across the country. Additionally, networking for alumni outings and all industry at events such as the Katie School Golf Classic and this Katie School Hall of Fame are promoted. The Katie School is a good steward of the funds provided, and details of how the funds are used can be found on the next page of this program.



HIGH RETENTION AND GRADUATION RATES

Illinois State students complete their degrees on time. ISU's retention rate remains among the highest in the nation at over 81.3 percent, and our high graduation rate (66.3 percent) is well above the national average.



FIRST-CHOICE

Illinois State has welcomed our largest freshman class in history. We enroll more than 21,500 students, while maintaining academic quality and small class sizes.



DIVERSE CAMPUS

Illinois State provides accessible opportunity and increasingly reflects the nation's changing demographics. We enrolled our most diverse freshman class in school history this year with 41 percent of these students and nearly 32 percent of the total student population coming from traditionally underrepresented groups.



BANG FOR THE BUCK

Illinois State is ranked among the top universities for return on investment. U.S. News & World Report recognized the University as one of the Best Value Schools in the nation, and Washington Monthly included the University on the Best Bang for the Buck list in the Midwest. In addition, the University was also ranked among the top 30 percent of four-year higher education institutions for graduates' return on investment.



RECORD FUNDRAISING

Illinois State University raised more than \$35.4 million in private support, reaching its third highest private support total in university history. Through these donations, more than 4,474 scholarships were awarded last fiscal year and 85 new scholarships were created.



TOP PUBLIC UNIVERSITY

Washington Monthly ranked the University in the top 106 out of all public national universities for the institution's contribution to the public good through social mobility, research, and public services. Illinois State made U.S. News & World Report's 2024 rankings of America's top public schools, at No. 112. In addition, the University was ranked in the upper echelon of Money's 2024 list of Best Colleges in America for quality education and affordability.



CIVICALLY ENGAGED CAMPUS

Illinois State's campuswide commitment to our core value of civic engagement has earned us recognition with the Elective Classification for Community Engagement, as an Excellence and Innovation Award for Civic Learning and Community Engagement recipient, and as a Voter Friendly Campus.


