Description of Opportunity

The 2025 Risk Management Summer Internship supports multiple Risk Management initiatives including property and insurance renewals, property statement maintenance, and loss control site visits, and introduces the candidate to Schnucks' corporate culture.

This role requires 4 days in the office, 1 day remote, and is located in St Louis, Missouri.

Essential Responsibilities:
